5.0 TIME SCHEDULE / COMPLETION PERIOD

CONTRACTOR shall be required to complete the WORK as per the Guaranteed Completion Date stipulated in the CONTRACT so as to achieve the Guaranteed Completion Date in accordance with the following milestones:

a)	Mechanical Completion	36 Months from Effective Date of Contract
b)	Preliminary Acceptance	41 Months from Effective Date of Contract

The "Effective Date of Contract (EDC)" shall be reckoned as "Seven months from the date of issuance of this LOI (Letter of Intent) by the OWNER".

In case Mechanical Completion is completed before the scheduled completion date (i.e. 36 Months from EDC), TFL shall provide Raw Material and Utilities as per the schedule given under Amendment No. XXVII dated 15.02.2019 reckoned prior to the end of the date of scheduled Mechanical Completion date (i.e. 36 Months from EDC) and WUHUAN shall not claim any compensation on account of such early Mechanical Completion and TFL shall not be held liable for any time or cost implications owing to such early completion.

Further, wherever TFL has any obligations to perform any work / activity w.r.t. Mechanical Completion, the phrase "Mechanical Completion" shall be read as "Scheduled Mechanical Completion date (i.e. 36 Months from EDC)".

7.0 SIGNING OF CONTRACT AGREEMENT

LOI No.: TFLYBROJIC&P/LOI/AMMONIA-UREA/2019-20/002 dated 19.09.2019

WUHUAN shall give their unconditional acceptance of this LOI within 15 (fifteen) days from the date of issuance of this LOI. Thereafter, a Contract Agreement (to be executed on non-judicial stamp paper of appropriate value) as per Annexure 1.24 (and subsequent revisions, if any) shall be executed between the OWNER and the CONTRACTOR within fifteen (15) days from date of acceptance of this LOI.

CONTRACTOR shall sign the CONTRACT AGREEMENT (in two sets) and return both the sets to the OWNER. The CONTRACT AGREEMENT shall be signed by authorized officer of the CONTRACTOR, in whose name Power of Attorney has been issued.

8.0 CONTRACT SECURITY CUM PERFORMANCE BANK GUARANTEE

As a Contract Security, CONTRACTOR shall be required to furnish a Security cum Performance Bank Guarantee (CS cum PBG) equal to ten per cent (10%) of the TOTAL CONTRACT PRICE as per Annexure- 1.16 and subsequent revisions, if any within thirty (30) days of issuance of this LOI in accordance with clause no. 35 of ITB (Instruction to Bidders, Part I, Section 1.0 of NIT) and other conditions as may be mentioned elsewhere in bidding document..

The Bank Guarantee shall be valid till Defects Liability period plus six months. However, on PRELIMINARY ACCEPTANCE of Plant by OWNER, the value of Bank guarantee shall be reduced to 5% of the TOTAL CONTRACT PRICE. In case of breach of contract the guarantee amount shall be payable to the OWNER without any conditions whatsoever. This Bank Guarantee shall be an irrevocable Bank Guarantee. The OWNER shall issue the authorization for reduction of PBG within 15 days from the receipt of request from the CONTRACTOR.

Other terms and conditions as mentioned in bidding document shall remain unchanged.

9.0 MOBILISATION ADVANCE

The provisions of Mobilization advance shall be governed by clause no. 14.2 and 14.3.1 of 'Special Conditions of Contract' (Section 3.0 of Part I of bid document) and subsequent amendments thereof including other clauses/provisions appearing elsewhere in the bidding document, except that the first instalment of Mobilization

advance (upto 6%) shall be due after 6 months from the date of this LOI (i.e. after 19.03.2020). Other terms and conditions remain unchanged.

10.0 MONTHLY PAYMENT SCHEDULE (S-CURVE)

The Mobilisation Advance shall be governed by Cl. No. 9.0 above of this LOI and relevant clauses of NIT document and subsequent Amendments thereof. Further, EDC (Effective Date of Contract) definition shall be as per Cl. No. 5.0 above of this LOI. The relevant paras/clauses of "Monthly Payment Schedule (S-curve)" submitted by WUHUAN with their Supplementary Price Bid shall stand amended accordingly.

11.0 DEEMED ACCEPTANCE

The provisions of "Deemed Acceptance" shall be governed by clause no. 16.0 and 18.12 of 'Special Conditions of Contract' (Section 3.0 of Part I of bid document) and subsequent amendments thereof including other clauses/provisions appearing elsewhere in the bidding document with following change:

Deemed Acceptance period shall commence from the date of Schedule Mechanical Completion (i.e. 36 months from EDC) or actual Mechanical Completion, whichever is later. Even if, WUHUAN achieves Mechanical Completion before the schedule Completion date, the Deemed Acceptance period (as per NIT document and subsequent Amendment(s), thereof) of 10 months shall start from the date of Schedule Mechanical Completion (i.e. 36 months from revised EDC).

Other terms and conditions as mentioned in bidding document shall remain unchanged.

12.0 PUBLIC PROCUREMENT (PREFERENCE TO MAKE IN INDIA) POLICY

As WUHUAN has given undertaking in their bid document that they are eligible for benefit under Purchase Preference (linked with local content) and that they will meet the mandatory minimum Local Content requirement of 50% specified in tender document, accordingly, the provisions of the said policy contained in Annexure 1.32 of the bidding document shall be applicable.

All other terms and conditions shall be as per NIT ref No. PNMM/PC009/E-4002 dated 29.09.2017 and all subsequent Amendments and other documents/correspondences referred at SI. No. 1.0 above of this LOI.
