As per the Revised DPR, the execution period for Railway Siding project (involving major Civil, Electrical and Supply) is considered as 24 months. Further, significant time (about 06 months) was involved for re-submission of the Revised DPR to ECoR, in view of MCL not agreeing for handing over of the land in 'Y' section area. Against the above backdrop, the PMC needs to be finalized at the earliest. 2. PDIL had already considered RITES as PMC under their PMC contract for the Railway Siding project. 3. The normal limited tendering cycle complying all the laid down C&P procedures for finalization of new PMC for the Railway Siding Project may entail a delay of about 04 to 05 months. 4. M's RITES is presently undertaking all the development works of Railway infrastructure and logistics in the Talcher region and currently undertaking the Railway works for NALCO, MCL & NTPC. 5. M's RITES Ltd., being a reputed company in the field of railway Infrastructure under Ministry of Railways, GOI, have the required credentials for execution of many similar works. The recent HURL projects in Gorakhpur, Baruani & Sindri for the construction of new Railway Siding facilities were awarded to M's RITES as PMC on nomination basis, and presently these three projects are in commissioning phase of the project. 7. It may be noted that the Feasibility Study Report (FSR) & Detailed Project Report (DPR) have been prepared by M's RITES.
