7.0 SIGNING OF CONTRACT AGREEMENT

WUHUAN shall give it's unconditional acceptance of this LOI within 15 (fifteen) days from the date of issuance of this LOI. Thereafter, a Contract Agreement (to be executed on non-judicial stamp paper of appropriate value) as per Annexure 1.24 (and subsequent revisions, if any) shall be executed between the OWNER and the CONTRACTOR within fifteen (15) days from date of acceptance of this LOI.

CONTRACTOR shall sign the CONTRACT AGREEMENT (in two sets) and return both the sets to the OWNER. The CONTRACT AGREEMENT shall be signed by authorized officer of the CONTRACTOR, in whose name Power of Attorney has been issued.

8.0 CONTRACT SECURITY CUM PERFORMANCE BANK GUARANTEE

As a Contract Security, CONTRACTOR shall be required to furnish a Security cum Performance Bank Guarantee (CS cum PBG) equal to ten per cent (10%) of the TOTAL CONTRACT PRICE as per Annexure- 1.16 and subsequent revisions, if any within thirty (30) days of issuance of this LOI in accordance with clause no. 35 of ITB (Instruction to Bidders, Part I, Section 1.0 of NIT).

In addition to submission of the Security cum Performance Bank Guarantee (CS cum PBG) for 10% of the TOTAL CONTRACT PRICE as stipulated above, CONTRACTOR is also required to submit a separate Bank Guarantee for an amount equivalent to 100% of the license fees for Gasification [as quoted under Sl. No. 1.0, Part-II, Section A Gasifier of Annexure 1.2 OR as payable by LSTK contractor to Air Products (formerly Shell) as per License Agreement, whichever is higher]. The CONTRACTOR shall submit to TFL a copy of the License Agreement signed between CONTRACTOR and Air Products (formerly Shell) indicating inter alia the License fees payable by CONTRACTOR to Air Products (formerly Shell) (as documentary proof). The above BG shall be submitted within Sixty (60) days of issuance of this LOI. The format of BG shall be as per Annexure-1.35 (and subsequent revisions, if any) and shall be issued by any bank appearing in the list as per Annexure 1.20 (and subsequent revisions, if any). The BG shall be valid till PRELIMINARY ACCEPTANCE plus 3 months. This Bank Guarantee shall be an irrevocable Bank Guarantee.

9.0 PUBLIC PROCUREMENT (PREFERENCE TO MAKE IN INDIA) POLICY

As WUHUAN has given undertaking in their bid document that they are eligible for benefit under Purchase Preference (linked with local content) and that they will meet the mandatory minimum Local Content requirement of 50% specified in tender document, accordingly, the provisions of the said policy contained in Annexure-1.33 of the bidding document shall be applicable.

10.0 INTEGRITY PACT

This contract shall be governed by INTEGRITY PACT (Annexure 1.25 and revisions, if any) signed between TFL and WUHUAN.
